**Terms & Conditions:**

- 1) Damage to Premises: The Party accepts, that any work carried out by the Party and/or its contractors at "Namma Metro", shall not affect or damage the civil structure, façade(s), flooring, cable works, any part of "Namma Metro" within or outside. The Party shall be liable for all damages to rented space and, upon demand, shall reimburse to BMRCL for the cost of the repair of the rented space or any other damage elsewhere within the Station premises caused by or arising from the installation or removal of property from the licensed space or from the removal of Party's property upon the expiration or earlier termination of this License Agreement.
- 2) Any damage, if caused, shall be the sole liability & responsibility of the Party and the decision of BMRCL in this regard shall be final and binding. BMRCL reserves the right to deduct repair cost from the security deposit. If the repair exceeds the deposit, the party agrees to make good the actual expenditure incurred for the damage caused within 3 days after intimation by the first party.
- 3) The Party will not make any permanent structure at the location and will use only temporary modular arrangements for the purpose required and agreed.
- 4) The operational timings of the activities are limited to 7 AM till 10 PM.
- 5) The actual occupancy of the space taken by the Party is of the essence of this application. If the Party does not occupy such space under the terms and conditions set forth herein under, the BMRCL is authorized to occupy such space or allot the said temporary space to any other applicant without in anyway releasing the Party from any liability hereunder. The BMRCL reserves the right to relocate Exhibitor to space other than specified location. No inconvenience, damage / loss in any means shall be caused to any other occupier, commuter, staff of Namma Metro, by the Party or its representatives during the work and activity.
- 6) The Party shall not display anything, which shall be or is likely unfair, illegal, unlawful, immoral, or the like and shall comply with extant rules and regulations of relevant government agencies.

- 7) Statutory licenses: If there are any licenses, authorizations, or permits required by any governmental agency or authority for the type of activity to be carried on at or for the use of the licensed space, the Party shall be responsible for obtaining such. No unlawful activities shall be permitted in the use of the licensed space.
- 8) Hazardous Material: Licensee shall not cause or permit any hazardous material to be brought upon, stored, kept, used, or discharged on or about the Leased Premises.
- 9) In case required, BMRCL reserves the right to relocate the location of promotional opportunity to a mutually agreed location between BMRCL and Party.
- 10) The BMRCL reserves the right to Stop/Cancel the Promotional Opportunity through a written notice.
- 11) The BMRCL shall permit the Party for installation of the display at Promotional Opportunity location One Night Prior to the commencement date. The applicant will remove all such material on the night of expiry day of agreement or on the prior termination day of the agreement at their cost.
- 12) The Party shall not promote specific religious, political or social views in any way whatsoever. Solicitation is prohibited.
- 13) Signage: All signage must be of professional quality and approved by the BMRCL prior to the Commencement Date. Banner and hand-written signage is not permitted. The BMRCL reserves the right to remove, alter or relocate signs at BMRCL's sole discretion and without consequence from the Party or event participants.
- 14) Decoration. BMRCL shall have full discretion and authority in the placement, arrangement, and appearance of all items displayed by the Party, and may require the replacing, rearrangement, or redecorating of any item or of any booth, and no liability shall attach to BMRCL for costs that Party may incur thereby. All exhibits shall be ready by the opening hour of the Metro Train Services. The BMRCL will not allow any noise or moving of exhibits after this time. No exhibit may be built or erected to exceed the height limitations as set forth under this license.
- 15) Obstruction of commuter movement. The Party Shall ensure that there shall their demonstration or activity shall not obstruction of commuter movement and if in the BMRCL judgment there is obstruction, the Second Party shall abide by the directions of BMRCL.
- 16) Insurance: Exhibitor is advised to see that its regular company insurance includes extra territorial coverage, and that it has its own theft, public liability, and property damage insurance.
- 17) Care and Removal of Kiosk and promotional items: The Party must, at its own expense, keep Kiosk area clean. All promotional activity must continue until 10 p m each day during the license period of the closing time of the license period. On the day of the termination of the license period, the BMRCL shall commence the removal of the kiosk and other promotional items and complete the task by 11 pm In the event Exhibitor fails to remove its exhibit after this time and if the space is allotted to another licensee, them, BMRCL reserves the right, at Party's expense, to shift the exhibit through a carrier of BMRCL's choosing or to place the exhibit in a storage warehouse as it may deem desirable without any liability to BMRCL.

- 18) Kiosk Representatives: Kiosk representatives shall be restricted to Party's employees and their authorized representatives. Kiosk representatives shall at all times wear badge identification furnished by the Party. The Party may at any time limit the number of Kiosk representatives. However, if the Party chooses to outsource the Kiosk Representatives to a third party, the exhibitor shall be obliged to furnish the complete credentials of the people manning the kiosk. This being a security concern and the exhibitor shall comply this in full measure. All Kiosk must be staffed by the Party during all hours the BMRCL has scheduled the opening and closing of the kiosk time.
- 19) Sub-licensing/ Kiosk Usage: The Party shall not sub-license, assign or otherwise permit any person to occupy, licensed booth, or any part thereof, or use the booth for the exhibition of anything not specified in this License. Exhibits must solely be used for the purpose of promoting Exhibitor's products or services and shall not be used for other business purposes. Rulings of the BMRCL in its sole discretion shall in all instances be final with regard to use of any exhibit space.
- 20) Limitation of Liability: The Party agrees to indemnify and hold harmless the BMRCL, their respective officers, agents and employees, against all claims, losses, suits, damages, judgments, expenses, costs (including, without limitation, reasonable legal fees) and charges of every kind arising out of or resulting from its execution of this License or its occupancy of the space herein contracted for by reason of personal injuries, death, property damages or any other cause sustained by any persons or others. The BMRCL shall not be responsible for loss or damage to displays or goods belonging to Party, whether resulting from fire, storms, acts of God, air conditioning or heating failure, theft, pilferage, mysterious disappearance, bomb threats or other causes. All such items brought to the Kiosk are displayed at the Second Part's own risk, and should be safeguarded at all times. The BMRCL makes no representations or warranties with respect to the number of commuters or the demographic nature of Metro ridership. The Party confirms that it shall comply with all applicable rules, regulations and further agrees to indemnify and hold the BMRCL harmless from any and all claims, liabilities, damages or expenses arise out of Permitted Activity or noncompliance with any of rules/laws. The Party hereby indemnify and keep indemnified the BMRCL against any civil, and criminal liabilities including vicarious liabilities, attributable to the permitted promotional opportunities availed by the party. In the event of any claim being made against First Party, the Party shall, without delay, demur reservation and/or protest make good the same to the BMRCL. This indemnity provision shall survive the termination or expiration of this agreement.
